Changes/Cancellations Be sure to have your reservation acknowledgement num-
ber that was assigned to you when the reservation was made. (Modifications to payment
information cannot be completed online.) All credit card reservation cancellations received
after October 3, 2005, 4pm MST will be charged a \$25 cancellation fee. All cancellations for
rooms guaranteed by check deposit will be charged a \$25 cancellation/deposit fee per reser-
vation cancelled at any time. One night's room plus tax (currently 15.6%) deposit will be for-
feited if your entire reservation is not cancelled 72 hours prior to your scheduled arrival date.

The Housing Bureau must close 14 days prior to the meeting, to ensure all delegates
receive their acknowledgments and confirmations in a timely manner. All new reser-
vations inquiries will be directed to the hotels (if rooms are still available), or to the
Seattle Hotel Hotline (a consumer reservations service).
